WHAT WE DO

Training & Education

To strengthen the quality of services available to survivors and their loved ones across the state, NJCASA provides training and technical assistance to its 22 program members and allied professionals, including those who work in the fields of mental health, law enforcement, healthcare, public health, and public at-large.

Advocacy

NJCASA advocates for survivor-centered legislation and policies that help create a safer, more just society. Through close work with policymakers and partners across many sectors, we advance priorities to expand access to healing and justice.

Collaboration

NJCASA promotes meaningful partnerships to create a safer New Jersey. We partner with organizations and communities who are also seeking justice for survivors and working to end systemic inequality and oppression.

Over **1.8 million** survivors of sexual violence **live in N.J.** - nearly **20 percent** of our state's population.



Prevention

Sexual violence is 100% preventable and NJCASA's focus on primary prevention aims to address and reduce the social norms and power imbalances that allow violence to persist. Addressing these factors can help create cultural change as we work towards a world free of sexual violence.

HELP IS AVAILABLE

Survivors of sexual violence and their loved ones can call N.J.'s 24-hour statewide hotline at 800 - 601 - 7200 to be connected to support services closest to you.

Every county in New Jersey has a sexual violence program, which offers free services including:

- Supportive services: Confidential sexual advocates (CSVAs) are available 24 hours a day to provide support during hospital exams, police interviews, court appearances, and more.
- Counseling: Short-term individual or group counseling is available for survivors and their loved ones. Lengths of counseling services differ from center to center, but each one can provide a thoughtful referral to anyone looking for longer-term counseling and support.
